INTRODUCTION

We are so pleased that you are providing a performance opportunity for children aged 5-11 years, helping to celebrate their dance successes and build their confidence.

This U.Dance First support resource, aims to provide you with guidance and support to be able to plan your performance opportunity easily and smoothly to suit your setting and facilities.

U.Dance is a national framework which celebrates youth dance in a non-competitive, inclusive environment. We want to ensure that, at every level, children and young people can achieve, be inspired, and aim higher in dance in a safe and inclusive environment. U.Dance First is a strand of the U.Dance framework, as a first step into dance and performance.

WHAT IS THE U.DANCE FIRST PROGRAMME?

U.Dance First is simply a way to provide dance performance opportunities for children aged 5-11 years and then celebrate their performance success with everyone!

WHAT MIGHT A U.DANCE FIRST PERFORMANCE LOOK LIKE?

This could be as small as one class performing a short dance to an invited audience made up of parents and carers, or even to another class. We encourage you to work within your setting and resources capacity, no matter how big or small, as we believe that all children's dance performance activity can and should be celebrated.

There is no limit either to how big the performance can be, so it might be that groups from other schools or community settings also take part or that the performance or event is organised by an out-of-school setting or organisation. In short, it might include 10 dancers or 1,000! The emphasis of the U.Dance First programme is on getting primary aged children dancing, but events that include a wider age range of young dancers are very welcome to register too.

DOES THE U.DANCE FIRST PERFORMANCE OR EVENT NEED TO TAKE PLACE ON A STAGE?

No! It can take place in a school hall, in a classroom (with enough clear space), or in an out-of-school setting space, as well as on a stage if you have access to one. Whatever space you use, we do suggest that it is suitable for the capacity of performers and audience and that it is a safe and suitable space for dance activity.

WHY SIGN UP TO THE U.DANCE FIRST PROGRAMME?

One Dance UK are here to support you with your performance or event and will help you to shout about your pupils' or participants' successes.

We will:

- provide a certificate for all those taking part
- provide resources to support the delivery of dance (see page 7)
- provide guidance about putting on a performance or event
- help you to shout about your performance or event by including it in a U.Dance First regular e-bulletin and on our social platforms
- signpost to useful resources

As the national support organisation for dance and Subject Association for dance in schools, the more we know about nationwide dance activity, the more we can champion and advocate for it. By registering your event with us, you will be helping us to build a clearer picture and are playing your part in celebrating the importance of dance!

HOW TO REGISTER YOUR PERFORMANCE OR EVENT WITH THE U.DANCE FIRST PROGRAMME

1. Complete the 2025 [U.Dance First Registration Form](#).
2. We will then get in touch via email to find out more details about your performance or event and will send you all the supporting resources, signpost to other resources, and collect any performance information that you might want sharing via our social platforms.
3. Once your performance or event has taken place, inform us about its successes, and we will shout about it in our regular U.Dance First news e-bulletin.
4. In return for sending us your performance data, we will post out celebration certificates for each participant. (All data provided should adhere to a clear GDPR policy).

SOME IMPORTANT CONSIDERATIONS FOR YOUR PERFORMANCE OR EVENT

One Dance UK is committed to ensuring dance activity for children and young people is undertaken in a safe and inclusive environment.

Here are some important guidelines to help you plan for a safe and inclusive performance or event:

- your setting has a clear GDPR policy, which is adhered to.
- the performance or event is planned with safety in mind.
- the performance or event is fully inclusive for both participants and audience members.
- the performance or event will be non-competitive and all those taking part are celebrated.
- the performance or event will be well supervised with the correct ratio of adult to child supervision.
- first aid is available on-site and the setting's evacuation procedures are communicated with everyone attending and taking part.
- the creative content of the performance will be appropriate for a family audience.
- a robust safeguarding policy is in place: see our Planning and Delivering a Performance or Event for Children and Young People Support Guide on our website [here](#).

SAFEGUARDING

The performance or event, no matter how small, should have robust safeguarding procedures in place, demonstrating high standards of practice:

- ensure the Designated Safeguarding Lead is identified and is a point of contact for any concerns amongst all staff, participants and parents/carers.
- all staff involved should be trained in effective safeguarding practice and a safeguarding policy should be in place.
- this free safeguarding training: [One Dance UK, Safer Dance and High-Speed Training](#) is informative, and useful, for yourself or any adult supporting the performance, as additional guidance to support your safeguarding practices.

SUPPORT FOR YOUR PERFORMANCE OR EVENT

One Dance UK will provide the following support:

- social media promotion of your event from our dedicated Comms team at One Dance UK, should you wish to advertise your event, which is not a requirement of registering with the programme
- a U.Dance First logo and use of logo guidelines, which can be displayed on your school or organisation website, on any posters or any social media posts, if you wish to promote the performance
- suggested copy examples for social platforms or the school website
- the opportunity for your performance or event to be shouted about and celebrated in a dedicated U.Dance First regular e-bulletin
- certificates for all participants
- a thank you postcard with links to advocacy resources for you as the organiser and for any other group leaders of visiting groups

As well as all the above you will also be sent the following resources to support the delivery of dance, after completing the registration form and telling us a little bit about your performance:

- **CPD snippet 1: What is Dance?**
A short 15-minute filmed session for dance teachers that includes an introduction to the ingredients that make up dance: Action, Space, Dynamics, Relationships. This short session includes a mix of practical and theoretical exercises that can be undertaken with children and young people.
- **Dance Games:** This brand-new resource, which can be followed by both specialist and non-specialist dance teachers, provides a selection of engaging activities designed to get pupils moving, creating and having fun in your dance lessons.
- **Simply Dance - Actions Lesson Plan:** This lesson plan is the first in a series of seven that form the 'Simply Dance - Actions' scheme of work designed to introduce and develop dance-specific knowledge and skills in pupils aged 5-6.
- **Dance in Schools Footwear:** This safe practice resource, focuses on the importance of bare feet for dance lessons in school. The resource includes specialist knowledge drawn from scientific publications, making it easy to embed the guidance into your risk assessment and safe practice policy.
